## **Message from the Secretary:**

The single most important item since the last Quarterly meeting was the following motion. Governors are reminded that a Governors' Motion to make the 2012-13 Governors' Meeting an Online meeting was passed in May

The motion was:

Moved: Paul Leblanc; Seconded: Lyle Craver

Whereas, feedback from the April 2012 CFC Quarterly Meeting indicated a projection of low attendance at the forthcoming 2012 AGM in Victoria, and;

Whereas, the experience of the 2011 AGM raises concerns about the possible marginalization of those attending an AGM remotely;

BIRT the 2012 CFC AGM be held online from 2012 July 2-8, in accordance with the rules governing the federation's quarterly meetings;

BIFRT electoral ballots will be kept confidential, both publicly and within the assembly.

We will be requiring a supermajority of 2/3 for passage of this motion. In addition, to quote Lyle: "Bear in mind that this is a 'for all time' type measure - not just for when the meeting happens not to be in Ontario!"

  - I am optimistic the membership numbers are finally heading upwards, hopefully on a sustained basis. If you check appendix 2 of GL3, the evidence was quietly revealed. Membership as of Feb 1, 2012 stands at 1873, up from 1821 as of May 1, 2011.

It is nothing earth shattering, we have had these fluctuations before. However, I tend to believe it is the start of a longer trend. It is consistent with the trend I see at the club level. Well, at least at the 3 clubs I visit, Mississauga, Hamilton, and Burlington. Individual club results may vary.

## FIDE Report (Hal Bond)

## **Development Commission**

I returned from Athens yesterday evening after a meeting of the FIDE Development Commission. Though the meeting was productive, my new laptop died within 3 hours of arrival. The Development Commission (formerly CACDEC) identifies Federations with financial and technical needs and allocates resources with the goal of increasing FIDE activity.

The 2012 budget (in Euros)for the Continents are: Africa 70,000 Americas 43,750 Asia 35,000 Europe 13,125

In addition to these amounts, FIDE offers 15,000 in activity rebates as well as youth travel grants (to the WYCC of World Junior) to youth players in developing countries who score well in Continental Championships.

A useful tip came to light for players and organizers wishing to build up our FIDE rating pool. A 10 player RR with 4 rated players can produce official FIDE ratings for the 6 unrated players in a single tournament, provided that the unrateds score a point against rated opposition. Although this is in the FIDE Handbook it is not well understood.

## **World Championship Match**

I leave for Moscow on May 8 for the Anand - Gelfand match. As Deputy Arbiter, this will be my 6th time working with the Chief Arbiter, Armenian IA Ashot Vardapetyan. It was a great honour to be selected by the players themselves. With any luck my next laptop will survive and I can stay in touch with the motherland!

## Istanbul Olympiad, August 27 - September 10

As Michael von Keitz has indicated, our teams have been named with one or two cavaets. The players will now select their Captain(s). Though several candidates were approached, we were unable to recruit an Olympic Co-ordinator so these tasks have fallen to a coalition of the willing. Our fundraising campaign is underway but we are unlikely to raise the full amount from donations and tournament activities. Therefore I hope the Governors can support the commitment to fully fund our teams in the event of a shortfall.

I have sensed over the past few years that our Olympic enthusiasm, perhaps due to the bourgeoning FIDE calendar, has waned. This is disappointing. The Olympiad provides a unique opportunity for our top players to face off against the very best players in the world. Most of the world's elite players are not accessible – they play amongst themselves in round robins and matches. Without the Olympiad we

would not see Charbonneau beating Anand, or Bluvshtein toppling Veslin, or Roussell-Roozmon scoring a 20 game GM norm to earn the title. We have so little to offer our elite players. They give us two weeks of their time to represent our country. They should not have to pay for this privilege. Please let us give them their chance to shine!

## 6a. Public Relations Coordinator Report

Public Relations Coordinator Report - Bob Armstrong, CFC Public Relations Coordinator

Bylaw 3 of the CFC Handbook, under Duties of Officers in Section 8C, gives the mandate of the Public Relations Coordinator position ( created at the 2010 AGM ) as:

- "8C. The Public Relations Coordinator will be responsible for promoting the image of the CFC and for promoting chess generally to the public. As such the Public Relations Coordinator will, among other things:
- deal with mainstream media to promote significant chess news, such as Canadian Chess Champions, a new Canadian GM, major tournaments like the Can. Closed, Canadian Open, Can. Women's Closed, CYCC, etc., the various benefits accruing from playing chess and other positive aspects of the chess culture. "

Here is the update on activity since the 2012 Winter Meeting ( Jan./12 ):

- 1. "News" items (on the CFC Website Homepage under "Latest News" [copies on the CFC "News" Discussion Forum, Facebook, and Twitter]) Posted 43 news items (to and including April 1). In particular, have started a series of posts promoting the new "quick chess rating system" to Canadian organizers (and have posted on numbers of discussion board threads, where appropriate, about the new CFC system, that now parallels the normal "regular rating" system).
- 2. Press releases: issued 1:

Bond - Canadian Deputy Arbiter for 2012 World Chess Championship!

- 3. Discussion Boards: posted numbers of times on the members' CFC Chess Chat Forum, and the CMA ChessTalk, answering CFC issues raised.
- 4. New Media Links: I have been provided by members with media links across the country, and will slowly be integrating them into the CFC Media E-mail Groups as time permits.
- 5. New CFC Facebook Non-Profit Corporation Page: have continued incremental building from about 100 "Likes" in January, up to 121 by April. Adopted early the new FB page format change, and introduced Banner Picture of public playing chess outside with large chess set. The majority of "likes" are not CFC tournament players, and many are not CFC members. We are reaching out in the social media to the non-CFC public.

## 6c. CFC Membership Drive Committee Report

Based on the last emails I received from my committee members in March, the CFC Membership Drive Committee has sent emails to a total of at least 1800 ex-CFC members' addresses to date (from a list of 2167 that Executive Director Gerry Litchfield sent to me in October 2011), asking these ex-CFC members to rejoin.

While the rate of emails sent to ex-CFC members by this committee became not quite half of what it was at the end of December (at least 1300 were sent by then), we are still well on track to achieving our committee's goal of finishing sending emails to all the ex-CFC members on our list before 1 July 2012.

Our committee's emails to ex-CFC members asked them to contact Gerry, rather than committee members, if they wished to rejoin the CFC, as I stated in my January report. In handling my own share of emails, I found that, starting in January, some (7) of the ex-CFC members that I had emailed replied to me indicating that they had already rejoined the CFC.

Since ex-CFC members on our list were instructed to contact Gerry if they wished to rejoin, it is somewhat difficult to judge the success of our committee's efforts so far. As of December, six ex-CFC members had elected to at first contact committee members (instead of Gerry) to indicate that they wished to rejoin, as I stated in my January report. This number of six known positive reponses still had not changed by the end of March.

However, a hint of more possible success is provided by looking at recent CFC membership stats. As I mentioned in my January report, the total CFC membership for 1 May 2011 was 1821, and as of 1 January 2012 it was 1852. The total CFC membership for 1 February 2012 was 1873, as is noted in the 2011-12 GL #3, in Appendix 2 there.

This is an encouraging trend for the CFC, regardless, though as I noted in my January report, Gerry has stated that it would be best to compare a given month's total for the current year with the same given month's total of the previous year, to obtain a truer picture of the trend. Hence I look forward to seeing the 1 May 2012 CFC membership stats.

Kevin Pacey CFC Membership Drive Committee Chairman Based on the most recent quarterly data available (31 Dec 2011), the average rating of players active in the past 12 months was 1194. This continues a slow uptrend that began when the average bottomed out at 1138 in early 2009 after five years of downtrend. Last week the CFC office updated the CFC:FIDE comparisons and the numbers look quite stable <a href="http://www.chess.ca/cfc-vs-fide-rating-comparison">http://www.chess.ca/cfc-vs-fide-rating-comparison</a>

Incorrectly submitted junior events continue to cause me much work. Since the CFC office provides minimal quality control, I have to ferret out tournament details from websites and flyers and contact organizers to properly audit events. The most common error continues to be 30 minute events submitted for Regular rating. Despite the fact that the governors reconfirmed the policy on time controls at the last quarterly meeting, a few organizers continue to ignore the rules and the CFC office continues to improperly rate junior events. Apparently, the statement of duties does not include any screening of rating submissions and there is no requirement for organizers to report the time controls for their events.

As promised, I have prepared a motion to replace the existing bonus point system with a better one. The new bonus point formula contains two components - a bonus for achieving a lifetime high rating and a bonus for gaining an exceptional number of points in a single event. I believe that the new formula will help address the issue of under-rated juniors since these criteria are very often met in junior events. The formula is based on a tremendous amount of work done by Roger Patterson and I owe him a great deal of thanks.

I have presented two other motions, one which proposes that we publish rules for rating internet events and one which spells out clearly in one place in the handbook what the CFC expects for events to qualify for rating.

I hope to see most of you at the AGM in Victoria in July!

## 7. 2012-H TDOCP Motion (Ong/Bond)

## **Motion 2012-H TDOCP Motion**

Moved by: Simon Ong, Seconded by: Hal Bond

Moved adding the following regulation to current section 20 of the CFC Handbook

## Regulations:

- 1. Introduction
- 20.1 The following regulations can be altered by the CFC executive with the recommendation from the TDOCP committee members.
- 20.2 The titles for award are the Regional-TD (RTD), Regional-Organizer (RO), National-TD

- (NTD), and National-Organizer (NO).
- 20.3 Individuals with National-TD (NTD) and National-Organizer (NO) will qualify to apply for the FIDE arbiter and organizer titles (NA, FA, IA, and IO).
- 20.4 The titles are valid for life from the date awarded. Licence fee will be charge every 6 years.
- 20.5 The judging unit is the TDOCP committee members.
- 20.6 All applicants for these titles must be current CFC members.
- 20.7 All applicants must have at least 2 recommendations from 2 different people preferably FIDE-certified arbiter/organizer, CFC Executive/Governor and Provincial/Club Executive member.
- 2. Regulation for the Regional-TD (RTD)
- 20.8 Knowledge of the Laws of Chess, CFC Regulations for chess competitions outlined in the CFC handbook.
- 20.9 Skills in operating electronic chess clocks , SwissSys/SwissManager program, and computer (Words, Excel, Email).
- 20.10 Experience as tournament director in at least 4 CFC-rated events, including one Swiss and one Round Robin. The Swiss tournament must have at least 10 participants and the Round-robin must have at least 4.
- 3. Regulation for the Regional-Organizer (RO)
- 20.11 Knowledge of the organizing chess tournament, CFC Regulations for chess competitions outlined in the CFC handbook, and submission of CFC/FIDE reports to CFC office.
- 20.12 Experience as tournament organizer in at least 4 CFC-rated events, including one Swiss and one Round Robin. The Swiss tournament must have at least 10 participants and the Round-robin must have at least 4.
- 4. Regulation for the National-TD (NTD)
- 20.13 The NTD title is awarded only to those who have already been awarded the title of RTD.
- 20.14 Experience as tournament director in at least 4 CFC-rated events, including one national and/or international event. In order to count as a norm, the Swiss tournament must have at least 20 participants and the Round-robin must have at least 6.
- 20.15 Attend either FIDE Arbiters' Seminar or CFC TDOCP(TD) Seminar. You must pass the examination (80% +) given in either of the aforementioned seminar.
- 5. Regulation for the National-Organizer (NO)
- 20.16 The NO title is awarded only to those who have already been awarded the title of RO.
- 20.17 Experience as tournament organizer in at least 4 CFC-rated events, including one national and/or international event. In order to count as a norm, the Swiss tournament must have at least 20 participants and the Round-robin must have at least 6.
- 20.18 Attend either FIDE Organizer Seminar or CFC TDOCP (Organizer) Seminar. You must

pass the examination (80% +) given in either of the aforementioned seminar.

## 6. Regulation for CFC TDOCP Seminar

The list of lecturers shall be nominated by the TDOCP committee. There should be at least one lecturer in each province. The lecturer can be FIDE arbiter/organizer and/or National certified TD/organizer.

- 20.19 The TDOCP (TD) seminar will be a full day discussing the following topic:
- (a) Laws of Chess
- (b) CFC Rating System & Regulations for chess competitions outlined in the CFC handbook.
- (c) SwissSys/SwissManager Program
- (d) Use of the electronic clocks
- (e) Directing FIDE-rated Events
- (f) Other topics suggested by the TDOCP committee.
- 20.20 The TDOCP (Organizer) seminar will be a full day discussing the following topic:
- (a) Laws of Chess
- (b) CFC Rating System & Regulations for chess competitions outlined in the CFC handbook.
- (c) SwissSys/SwissManager Program & Submission of tournament report to CFC.
- (d) Topics from Chess Organizer's Handbook
- (e) Organizing FIDE-rated Events
- (f) Other topics suggested by the TDOCP committee.
- 20.21 The TDOCP Committee will prepare multiple choice/written examinations for each seminar. The participants must achieve 80% or above to pass the examination.
- 20.22 NTD and NO applicants who fail the examination must wait one month before taking the examination the second time.
- 20.23 The cost of attendance of TDOCP seminar (including the examination fees) will be decided by the TDOCP Committee members. The money collected from the TDOCP seminar will be submitted to the CFC office. The CFC office shall pay the lecturer on the basis of the number of participants.
- 20.24 The details to the TDOCP seminar (i.e. date, address, lecturer, etc) must be approved by the TDOCP committee one month before the starting day of the seminar.

## Certificates & Pins

1. Qualified applicants may request a certificate and "CFC TD/organizer" pin at the cost of \$15 (not including tax). The \$15 includes shipping.

There was an amendment to motion 2012-H as follows: Pacey/Palsson

Just before 'Certificates and Pins', etc., near the end of the text of Motion 2012-H, insert the following Regulation as an amendment:

## 7. Regulation for retroactively awarded TD titles

Notwithstanding regulations 1, 2 and 4 above, the title of RTD shall be awarded for life retroactively to current CFC members who prior to 1 January 2012 have directed at least 40 CFC-rated events, and who apply to receive such a retroactively awarded title. Similarly, the title of NTD shall be awarded for life retroactively to current CFC members who prior to 1 January 2012 have directed at least 60 CFC-rated events, and who apply to receive such a retroactively awarded title. For such retroactively awarded TD titles, Licence fee will still be charged every 6 years.

## CFC Governor's and Executive Member's Code of Conduct

## Part I: decision making process

The Assembly of Governors is committed to effective decision-making and, once a decision has been made, speaking with one voice. Towards this end the Governors will:

- Speak from broad member and community interests
- Speak for themselves ("my own thinking on this is that...") rather for than a group of members.
- Express additional or alternative points of view and invite others to do so too.
- Refrain from "lobbying" other Governors outside of board meetings that might have the effect of creating factions and limiting free and open discussion.
- On important issues, be balanced in one's effort to understand others and to make oneself understood.
- Once made, support, indeed defend, Assembly of Governors decisions, even if one's own view is a minority one.
- Respect the confidentiality of information on sensitive issues, especially in personnel matters.
- Refrain from speaking for the organization unless authorized to do so.
- Disclose one's involvement with other organizations, businesses or individuals where such a relationship might be viewed as a conflict of interest. Involvement in chess clubs Leagues and Provincial Association, whether affiliated or not, does not constitute a conflict of interest.
- Refrain from giving direction, as an individual Governor, to the Executive Director or any

member of staff.

- Do not publicly comment on the performance of any arbiter or organiser. Direct complaints against arbiters or organisers to the relevant CFC Committee: NAC for rules of the game, Ethics for matters set out in the CFC Code of Ethics or TDOCP, for failure to pay guaranteed prices.
- Do no supports any third party involved in a dispute when a case is pending at the NAC, the Ethics Committee or the TDOCP.

## Part II: Duties and Ethics

Goal: To establish a set of principles and practices of the CFC Assembly of Governors that will set parameters and provide guidance and direction for board conduct and decision-making.

Code: Members of the Assembly of Governors of the CFC are committed to observing and promoting the highest standards of ethical conduct in the performance of their responsibilities on the Assembly of Governors of CFC. Assembly members pledge to accept this code as a minimum guideline for ethical conduct and shall abide by it.

Scope: This Code also applies to all Governors, to the members of the CFC Executive and to the members of all CFC Committees event if they are not a Governor.

## Accountability

- 1. Faithfully abide by the Articles of Incorporation, by-laws and policies of the CFC
- 2. Exercise reasonable care, good faith and due diligence in organizational affairs.
- 3. Fully disclose, at the earliest opportunity, in formation that may result in a perceived for actual conflict of interest.
- 4. Fully disclose, at the earliest opportunity, information of fact that would have significance in board decision-making.
- 5. Remain accountable for prudent fiscal management to association members, the board, and non-profit sector, and where applicable, to government and funding bodies.

## **Professional Excellence**

- 6. Maintain a professional level of courtesy, respect, and objectivity in all CFC activities
- 7. Strive to uphold those practices and assist other CFC members of the board in upholding the highest standards of conduct

## **Personal Gain**

8. Exercise the powers invested for the good of all members of the CFC rather than for his or her personal benefit, or that of the province they represent.

## **Equal Opportunity**

- 9. Ensure the right of all association members to appropriate and effective services without discrimination on the basis of geography, political, religious, or socio-economical characteristics of the province or region represented.
- 10. Ensure the right of all association members to appropriate and effective services without discrimination on the basis of the organization's volunteer or staff make-up in respect to gender, sexual orientation, national origin, race, religion, age, political affiliation or disability, in accordance with all applicable legal and regulatory requirements.

## **Confidential Information**

11. Respect the confidentiality of sensitive information known due to board service.

## **Collaboration and Cooperation**

- 12. Respect the diversity of opinions as expressed or acted upon by the CFC Assembly of Governors, committees and membership, and formally register dissent as appropriate.
- 13. Promote collaboration, cooperation, and partnership among association members.

Allegation of violation of this code shall be investigated by the Assembly of Governors.

Rnew is the post-event rating and Rold is the pre-event rating;

and RatingMaxBonus, RtgChangeBonus, and RtgChangeThreshold are constants with the following values:

RatingMaxBonus = 20; RtgChangeBonus = 1.75; RtgChangeThreshold = 13.

This issue was raised in the Rating Auditor Report during the January 2012 Governors Meeting. Motion: That an article be added to the CFC Handbook Section 7 CFC Rating System as follows:

"Events played over the internet may be submitted for CFC rating provided that:

- i) Conditions of play are advertised ahead of the event and agreed to by all participants"
- ii) A non-playing TD must be present at each playing site to ensure that normal tournament regulations and playing conditions are upheld.
- iii) Along with all the information that is usually sent to CFC, an event that has games played on the internet shall also provide the following information:
- a) moves from games played over the internet
- b) The names of TDs present at each site,
- c) provide the website where the games took place.
- d) provide the internet handles of the participants.

From an administrative standpoint, the delay in my having received the permissions I needed was also frustrating, although it seems to have worked out in the end. As a sidenote, my thanks go out to Chris, again, for making the number of polling options unlimited - this may prove handy in future.

The meeting was not all doom and gloom, of course, and I think we have a number of positives to show for our efforts: a solid budget in place, presented prior to the AGM; an improved bonus point formula voted in; Bob G.'s Youth Report finally presented and discussed; a new TDOCP on the books (controversial, as it may be); and a revised Olympic Selection Committee structure (imperfect as the whole process still might be). The last-minute inclusion of a Long-Term Planning Committee Report was also pleasing - Vlad Drkulec has been steering a strong team and I expect his report in July will be worth the wait.

Olympic fundraising will continue, but, as the discussion raised by Hal highlights, this is a challenge that may call for creative solutions down the line. In the meantime, each of you is encouraged to consider either putting on, or participating in, a waive event. I also encourage each of you to consider the development of bids for the 2013 Canadian Open and/or 2013 CYCC. With the 50th anniversary of the Canadian Open upcoming, it would be a shame to see a rescue bid prove necessary.

If the desire for further discussion is still burning inside of you, always feel free to turn to the governors' private discussion forum. With that, my thanks to all for participating in this meeting and I hope all of you will take the time to participate in the AGM come July (whether in person, by proxy, or otherwise).

As a postscript, my public congratulations to Hal on his appointment as a deputy arbiter at the World Championship. I wish him safe travels to Moscow come May.
